

## DEED OF TRUST



And whereas it is necessary that the objects of the trust created by the above declaration there of be previously recorded in writing and therefore it is hereby declare as under that :-

**1. NAME OF THE TRUST :-**

**BHAI NITIN KUMAR EDUCATION & SOCIAL WELFARE TRUST,**

The head office of the trust shall be Rajasthan The Trustees are liberty to shift the same to such other place as may be decided by the trustees from time to time. The trustees shall have power to open such other offices branch offices, and trough out India and aboard as may be determined from time to time.

i. To sponsor, open, take over, organize, establish maintain and promote or run educational institution i.e. colleges, universities, deemed universities, academies, laboratories, competition examination Training centers for admission in deferent courses or for services libraries, schools and the likes through out India & abroad.

ii. To promote education and research in art, sciences, medicine, herbal, environmental, social worker, agriculture, veterinary and other subjects of general public utility.

iii. To hold seminars arrange lectures, conferences exhibitions, or other meetings/events for dissemination of knowledge and advancement of culture fine arts and sciences.


society trust institutions or authority for promotion of education, literature, science, fine arts crafts, sports, cultural activities and the likes.

- vi. To give financial help aid loans or grants to any person, society trust intuitions organization or authority for the relief education or medical treatment of the poor and to carry out any other work for their relief and advancement of general public activity.
- vii. To provide research facility for carrying on research basic and applied in all system and disciplines of medical and surgical knowledge keeping in view the sociomedical and Socioeconomic needs of the affected community.
- viii. To provide encourage , initiate or promote facilities for the discover or the development of new methods of diagnosis, understanding and prevention of disease.
- ix. To arrange and provide such medical aid and such other assistance necessary for living to the needy persons who are otherwise incapable or handicapped or mentally or physically retarded and to financially uplift and person of poor class.
- x. To build up a trust devoted to the noble cause of nursing, medical, homeopathy , naturopathy , Electro Homeopathy , who would bring relief to the suffering and the sick by a simple and cheap method of treatment.
- xi. To create in students an awareness of social responsibility , a sense of patriotism, selling universal brotherhood.
- xii. To make students disciplined in conduct, refine in good behavior at reasoning and honest in the discharge of all their obligation with a special emphasis on the development of character and personality.
- xiii. To enter into any agreement with any government or authority, municipal local or otherwise, to obtain from such government university or such other authority any rights privileges concessions financial or otherwise that the trust may deem desirable to obtain and carry out exercise and comply with such arrangements rights privileges and concessions so acquired in furtherance of the objects of the trust.

The Trust is hereby expressly declared to be Public Charitable Trust and all the provision of this declaration are to be construed accordingly.



If any of its objects in whole or in part of any other provision of this declaration is found to be repugnant or inconsistent with any of the said provisions as are applicable on the relevant date, such objects or provision shall be deemed to be no nest to the extent of such repugnance or inconsistency and if any of the object of the trust is found to be invalid on the ground of vagueness or any other reason by a competent authority, it shall be deemed to have not been included in the objects of the trust so as to effect the validity of the trust.

**NOTHING** containing in this declaration shall be deemed to authorize the trustees to do any act which may in any way be construed as violative or contrary to the provision of section 2(5), 11, 12, 12-A, 12BA, 13, 35Cca, 35CC, 80-G or any other relevant provisions of the Income tax Act. 1961 or any statuoty modification thereof and all activities of the trust shall be carried on with a view to benefit the public at large without any profit motive for charitable purpose only as may be permissible under the provision of the income tax act. 1961 or the statutory modifications thereof  
**Ch. RamPratap Poonia the founder of the trust** hereby expressly authorized to add any other charitable objects in the objects or the trust provided , however it is a charitable object within the meaning of the Income tax act 1961.

**WITH** a view to attain the above objects or any or some of them the trustees may do all or any of the following acts and things :-

- i. To solicit, obtain, accept, offerings, subscriptions, Donation, grants, gifts, devices and bequests from founder or any person, firm , company, trust, society Central Govt. State Govt. or institutions interested in any of the objects of the Trust.
- ii. To acquire, by gifts, purchase,exchange, lease, on hire or otherwise how so ever any lands, building, easement, rights of common playgrounds, Praks and property moveable and immoveable and any estate or interest for the further once of all or any other objects of the Trust.
- iii. To accept and receive in any manner what so ever any cash or immoveable or moveable property unconditionally by any donor in furtherance of any one or more of the objects of the Trust.
- iv. To build, construct and maintain houses or other buildings and alter. Extend, improve, Repair, enlarge or modify the same with lights. Water . Drainage Furniture, fittings, instruments applicants and all other necessaries. For the use to **Secretary** **Bhai Nitin Kumar Education & Social Welfare Trust** **Sadulpur (Churu) Raj.** building is to be put or held.

- v. To construct or otherwise acquire, lay out, repair, extend, Alter, Enlarge, Improve and use land for recreation or pleasure grounds. Parks and or any other unmovable Property belongings to or held by the trust.
- vi. To Sell Mortgage, Let Lease exchange, Gift and otherwise transfer or dipuy of or Deal with all or any property moveable or immovable of the trust for the further anced of the objects of the trust.
- vii. To borrow and raise money with or without security or on the security of a mortgage, charge or hypothecation or pledge over all or any of the immovable or moveable properties belongings to the trust or in any other manner whatsoever.
- viii. To pay out of the funds belongings to the trust or out of any particular part of such funds all expense of the incidental to the formation of the trust and management and administration of any of the foregoing objects including all rents, rates, Taxes Outgoings and salaries of the employees.
- ix. To invest and deal with moneys of the trust not immediately required for any of its objects in determined from to time
- x. To draw, make Accept Endorse and discount cheque or things noisier other negotiable instruments.
- xi. To do all such other lawful acts, deeds or things as are incidental or conductive to the attainment of any of the objects of the trust.

#### **5. POWERS OF THE TRUSTEES.**

- a. Powers to controls and management of the whole affairs of the Trust as well as properties of the trust shall be vested in a body which shall be call the "**Board of Trustees.**" member where of shall be called be "**Trustees**"
- b. The Board of Trustees shall have full power to manage the affair of the trust and shall have unfettered discretion in applying the corpus on income of the trusts in furtherance of any of the objects of the trusts.

The board of trustees shall have the full power of delegate any or all the powers of the managements to any committee of trustees or any individual trustees or any other person or persons or officers or the trust and may revoke modify any such power from time to time.

- d. All moneys not required for immediate expenditure for the purpose of trust may be invested in any manner by trustees. Without Prejudice to the generally of the above the trustees may make the following investments.
  - i. Investment in conformity with the requirement of income tax act and any subsequent modifications made from time to time for the investment of Trust funds.
  - ii. Investment in moveable and immoveable properties, which may be authorized at any time by the board of trustees.
  - iii. Deposit in any scheduled bank financial institution firm or person from time to time.
- e. Unless other wise determined by the trustees, all bank accounts and deposits shall be opened, kept and made in the name of the trust and shall be operated by any one or more of the trustees or any person to which board of the trustees may authorise from time to time . All accounts of institutions run by the trust should be opened kept and made in the name of the institutions only by the trust and should be operated under the rules made by the trust.
- f. The board of trustees shall have the powers to raise loans (with or without security) accept gifts and donations, receive moneys securities instruments or other wise acquire any other moveable or immoveable property for and on behalf of the trust on such terms and conditions as the board may declare from time to time.
- g. The trustees may hold the properties of the trust for and on behalf of the trust in the name of any one or some of them as may be decided by the board of trustees from time to time.
- h. To take over and/or amalgamate any Institution and / or any place with identical and aims and objects of the Trust.



To make vary alter or modify schemes rules and regulations for carrying out the aims and objects of the Trust and for the management of the affairs there of and of running any Institution on in furtherance of the aims and objects of the Trust and otherwise for giving effect to the aims and achieving the objects of the Trust.
- l. The Trustees shall be chargeable only for such moneys, stocks, shares and funds as shall actually come into their hands and shall not be answerable or accountable for neglect, default acts or omissions or commissions of the other Trustees or of any bankers or other person with whom the Trust properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.
- m. To define and delegate administrative and financial powers, function to any of the office- bearers not otherwise provided .
- n. To consider and approve the budget estimates income and expenditures statements .
- o. To constitute Sub Committee / Advisory committees for such powers as the board may think fit with powers to Co opt members provided that in Special circumstance the chairman / Vice - Chairman/ Secretary Shall have the power to appoint such Sub Committees/Advisory Committee etc.
- p. To review the work done by the committees/Advisory Committees etc. and to vary amend, alter their decision, recommendations, if necessary.
- q. Any act, deed or thing required to be done or executed by the Trustee including endorsements of Govt. Securities shall be deemed to be done on behalf of all the Trustees if . It is done or executed by any one or more of the Trustees in Pursuance of resolution of the Board of Trustees.

It is expressly provided that the trustees may by a unanimous, resolution, register a charitable society under the societies registration act or any other Trust with the objects of the Trust, to which all the all of the assets and or income of the Trust may be Transferred and regulation where of shall be in conformity with the provisions of the trust with modification as may be agreed to by the trustees.

#### 6. QUALIFICATION OF THE TRUSTEES

The following persons shall be eligible to become the Trustee.

- a. He/She must be above the age of 18 years.
- b. He/She must be having full faith in the object of this Trust.
- c. He/She must not be a mad or insane person.

The Trustees may appoint new Trustees, can frame rules and impose conditions for new trustee membership, may refuse membership without assigning any reason.

The Trust may receive from or cooperate with the government any subsidy or help or assistance to promote its aims and objects. The Trust is a non-Political body. 

## OFFICE - BEARERS OF THE BOARD OF TRUSTEES

There shall be election after every 3 years to elect one Chairman, Vice Chairman Secretary and Treasurer of the Board of Trustees, the first office, bearers of the Board of Trustees shall be nominated by the founder of the Trust First office is "**BHAI NITIN KUMAR EDUCATION AND SOCIAL WELFAIR TRUST**" Ward No. 9, Behind Mohta Dharamshala, Shri Ram Kunj, Bus Stand Sadulpur, Distt- Churu (Rajasthan) 331023,

- i. Total number of trustees shall not be less than five and more than eleven including the first five founder trustees.
- ii. Subject to the maximum set out above the Board of trustees may appoint new trustees, from time to time who shall hold office of such period as may be decided by the trustees from time to time by simple majority.
- iii. The term of the new trustees shall be determined by the Board of trustees from time to time. A retiring trustee be eligible for reappointment on the expiry of his term.
- iv. The office of the Trustees shall be ISO factor vacated by reason of death or by resignation or becoming bankrupt or when a resolution to the effect is passed by the Board of Trustees with 2/3 majority.
- v. The Vacation of office of Trustees shall be in the case of death the date of death in the case of resignation from the date of resignation acceptance by the Trustees or with in 30 days which ever is and in other cases from the date when resolution to the effect is passed by the board of Trustees by 2/3 rd majority of votes.
- vi. Any Trustees nominated to fill up the seat vacated by any of the first five founder Trustees shall be treated as first founder Trustees.



### 7. MEETING OF THE TRUST :-

- i. That trustees shall hold one meeting at any place in a year to called the Anuual general meeting to transact the following businesses :-

- iii. The ordinarily meeting of the Board of Trustees shall normally be convened on seven clear days notice but an emergent meeting may be convened on a shorter notice by at least two Trustees/Chairman/Secretary.
- iv. Quorum of meeting shall be one third of total members of Trustees.
- v. The resolution of the Board of Trustees shall be deemed to have passed by majority vote. A resolution by circulation shall be valid as resolution passed in the meeting of the board, agreed to by 2/3 majority of the existing trustees.
- vi. The Trustees are also entitled to appoint in their place any other Trustees or any other person to represent them and for that written intimation on the prescribed form of proxy shall be used

**8. MANAGING COMMITTEE.**

- i. The board of trustees may constitute a managing committee and sub managing committees for the day to day working of the Trust and may delegate such power as may be decided by the Board of Trustees by majority.
